## ECKAN serves low-income persons in Coffey County

BURLINGTON — ECKAN (East Central Kansas Economic Opportunity Corporation) is a Community Action Agency started in 1966. The ECKAN Community Center in Coffey County provides a variety of services to people who meet the residency and income guidelines of 200 percent of the Federal Poverty Level. These services may vary based on the funding available. Coffey County ECKAN staff includes: Human Services Coordinator Heather Carver and Crisis Intervention Specialist Diane Rogala.

ECKAN provides Emergency Assistance to those who need assistance with rent, utility payments, any other emergency needs. ECKAN can assist with transportation for those needing to get to a medical appointment or a new job. ECKAN has a partnership with Thriftopia and can assist with the purchase of household and clothing items there. COVID-19 has affected many people in the community. ECKAN currently has funding for those affected by the pandemic. This funding has already benefited many in the county that have lost income during this time.

ECKAN offers a dental program for adults who need assistance with dental work. ECKAN knows that dental health is an important part of overall health.

ECKAN offers a savings program to assist families with starting an emergency savings account. Customers must make deposits into a savings account and meet with ECKAN staff for six months. If the customer successfully completes the requirements in the six months, ECKAN will match the deposits with a 2:1 deposit. This leaves the customer with an emergency savings account of \$1,000. This program typically takes place in the spring.

ECKAN offers Case Management services to assist customers with working toward goals. During Case Management, ECKAN staff can assist customers with paperwork they may need to fill out.

ECKAN has rentals available in Waverly and LeRoy. ECKAN manages the Section 8 Housing Voucher

program for Coffey County. ECKAN's Weatherization Department can assist families with weatherizing their homes. The Weatherization team will look at the areas of the homes that may need to be addressed to assist with better heating and cooling efficiency. This program applies to homeowners or renters with approval from their landlords that meet the income requirements. Applications for rental housing, Section 8 Housing, and Weatherization may be accessed at [ECKAN.org](http://ECKAN.org) or the ECKAN office can be contacted for more assistance.

ECKAN has a HeadStart home visitor, Kathy Sage, in Coffey County. Sage works with parents and children ages 0 to 5 in their homes that meet the income guidelines.

ECKAN assists families with school supplies in preparation for school. This program assists families with school supplies, school clothes, and school shoes. ECKAN believes children need the correct supplies to be successful in school. Coffey County ECKAN assisted 100 children with school supplies for the 2020-21 school year.

ECKAN is taking applications for the Holiday Bureau. In the past, families have been adopted and the adopter would buy gifts for the family members. This year ECKAN is hoping to avoid the spread of COVID-19 and would like to ask donors to consider giving gift cards or monetary donations. If you would like to do something different, call the office to discuss this. Monetary donations should be mailed to 1320 S Ash, P.O. Box 40 Ottawa, KS 66067-0040 or can be dropped off at the Coffey County ECKAN office, 409 Neosho St., Burlington.

At this time, Coffey County ECKAN services are by appointment only. Customers can schedule a time to meet with ECKAN staff by calling (620) 364-8223.
